


- Remus Riggs, born Jan. 12, 1790
 - Youngest child of Samuel Riggs
 - Inherited Pleasant Hill where he stayed until dying Dec. 18, 1867
 - Married Catharine Adams of Baltimore and had 6 children
- Samuel Rigg's son William inherited Pleasant Hill in 1867
 - Retired to Brookeville
 - Died 1906
 - Was the last member of the family to be buried in the cemetery
- Pleasant Hill Riggs Family Home through until 1913 sold to Austin T. Powell



- Samuel Riggs IV, Last Living Blood Relative,
- Cattleman, Philanthropist and former Northwest Baltimore Utility Construction Firm Official
- One of the Original Members of Troop 264, founded in 1927
- On Sept. 19, the truck Mr. Riggs was driving on Route 108 near his Olney farm hit a stopped car and then struck two trees.
- Died October 03, 2002—Age 82

Project Description

- Cemetery now on the common grounds of Brookeville Farms
- Over the years fell into ruin
 - Overgrown
 - Fallen trees

 - Headstones heaving out of ground and some completely fallen
 - Some stones stolen in the past






