Hello,

I am the president of the Germantown Historical Society (GHS), and also the

person responsible for the original sign in the Musser family burial ground at the corner of Clopper Rd. & Mateny Rd. (as president of the Germantown Citizens Association). The Germantown Historical Society is partly responsible for the current preservation of the burial ground with the present development, by being in contact with the developer and making sure that the burial ground would be preserved and the upkeep placed under the homeowners association.

I visited the burial ground this morning to check on it, as we do periodically, and saw that your group has put up a new sign. This pleased me immensely as the old sign needed to be replaced. It looks as if the development is preserving the burial ground, but the earth definitely needs to be shored up on two sides where there is a 6' sheer embankment.
