

STATEMENT OF SIGNIFICANCE

This was one of the oldest free Negro settlements in the County. At least as early as the Civil War period there were several families living here. By 1878, the church had been built and nearby families included the Boswells, Nolls, Bowers, and Plummers. Similar names appear on the headstones in the present cemetery. Adjacent to the cemetery is an old farmhouse presently owned by the Clagett family.
