

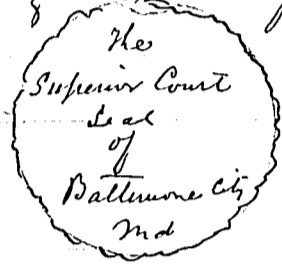
State of Maryland, City of Baltimore, to wit:

respective act.

At the request of Adeline & Mary HARRISS the following Deed was recorded
10th July, 1885. the 30th day of May 1879, to wit:-

This Deed made this 29th day of May in the year
Eighteen hundred and Seventy nine, by Solomon Williams and Sidney Williams
his wife, of Montgomery County and State of Maryland Witnesseth, that for and
in consideration of the sum of five dollars lawful money of the United States
to them in hand paid, the receipt whereof is hereby acknowledged. The said
Solomon Williams and Sidney Williams, his wife, do grant, bargain and sell
unto Adeline Harriß and Mary Harriß, both of said County and State, the following
lot of ground to be used as a burying ground - being part of the lot or parcel
of ground heretofore conveyed to the said Sydney Williams, by Samuel T
Stonestreet & wife, by deed bearing date on the 2nd day of July in the year
Eighteen hundred and Seventy eight, and recorded in Liber C. B. L. No 18,
folios 264, one of the Land Records books of said Montgomery County, said
lot being bounded as follows: Beginning at a stake now planted and running
North, seven degrees West, twelve feet to a stake; then South eighty eight de-
grees East, twelve feet to a stake; then South seven degrees East, twelve feet
to a stake; then North eighty eight degrees - twelve feet to a stake, containing
one hundred and forty four square feet, more or less.
