

At the request of Nomita von der Helde and Erik von der Helde, her husband and Amalia deM. Riggs, the following Leed was recorded April 20th, A. D. 1938, at 3:10 o'clock, P.M. to wit:-

This Deed made this 20th day of April, in the year nineteen hundred and thirty eight, by Margaret D. Beall, widow, Thomas C. Waters, unmarried, and Basil W. Waters, and Julia B. Waters, his wife,

Witnesseth, that for and in consideration of the sum of ten dollars and divers other good and valuable considerations us thereunto moving, we, the said Margaret D. Beall, Thomas C. Waters and Basil W. Waters and Julia B. Waters, his wife, do grant and convey unto Nomita von der Helde and Erik von der Helde, her husband, and Amalia deM. Riggs, as joint tenants and not as tenants in common, all those tracts, parts of tracts, pieces or parcels of land, situate, lying and being in Montgomery County, in the State of Maryland, being parts of tracts of land called "Charles and Benjamin" and "Brooke Grove", or by whatever name or names the same may be known or called, containing two hundred and twenty eight and three-fourths acres of land, more or less, and seventy five and one-half acres of land, more or less, fully described in a deed from Alletta M. Muncaster and husband to the said Margaret D. Beall, Thomas C. Waters and Basil W. Waters, bearing date the fifteenth day of February, in the year nineteen hundred and thirty five and duly recorded among the Land Records of said County in Liber No. 584, folio 390, less certain lots of land excepted from the second parcel as mentioned in said deed.

Saving and excepting, however, from the land so as aforesaid described those three parcels of land thereafter conveyed by the aforesaid grantors, as follows:

First: That parcel of land containing three-fourths of an acre, more or less, conveyed to John L. Hett and wife, by said Margaret D. Beall, widow, and others, by deed bearing date the twenty second day of March, in the year nineteen hundred and thirty five and duly recorded among the Land Records of said County in Liber No. 589, folio 171.

Second; that parcel of land containing three-fourths of an acre, more or less, conveyed to Stanley M. Brown and wife, by deed bearing date the twenty second day of March, in the year nineteen hundred and thirty five and duly recorded among the Land Records of said County in Liber No. 588, folio 173.

Third; That parcel containing one-half acre, more or less, conveyed to Clarence W. Albright and wife, by deed bearing date the twenty ninth day of March, in the year nineteen hundred and thirty eight and duly recorded among the Land Records of said County the second day of April, in the year nineteen hundred and thirty eight.

Subject, however, to the lease of the grantors to J. B. Riggleson which expires on the thirty first day of December, A. D. 1939, the Landlord terms of which the grantees assume and agree to perform and carry out, and subject also to the graveyard upon said farm, the right of ingress and egress to which is reserved by the grantors, their heirs and assigns, but that the said grantors agree to make no more burials in said graveyard.

Together with all and singular the buildings and improvements and all the rights, roads, ways, easements, advantages and appurtenances to the same belonging, or in anywise appertaining.

And the said Margaret D. Beall, Thomas C. Waters and Basil W. Waters and Julia B. Waters, his wife, covenant to warrant specially the land and premises hereby conveyed and to execute any and all such further and other assurances as may be requisite or necessary, the better to convey the same as aforesaid.
