St. Rose of Lima Roman Catholic Church is a fine example of a County Gothic Revival chapel. Constructed in 1883, the Church typifies the adaptation of high style Gothic Revival to a rural setting through the use of pitched gable roof, bracketed canopy hood, tall narrow windows and irregular massing. The Gothic influence is exhibited in the simple interior through the use of the Gothic arch form, ceiling ribs and wall brackets. The original character of the setting appears to be intact, with informally sited large trees and a graveyard to the side.

ACTION TAKEN

The architectural and historic significance of the Gaithersburg Vicinity resources identified on the Locational Atlas and Index of Historic Sites in Montgomery County were reviewed as part of this Master Plan. As a result of this evaluation, the Plan recommends the Master Plan for Historic Preservation be amended to include the following sites:

20/4 Nathan Dickerson Farm

- Excellent example of late Federal style frame farmhouse built around 1836.
- Associated with Nathan Dickerson, prominent citizen and two-time County Commissioner.

20/17 England/Crown Farm

- Victorian style structure with intricate bracket work and cornice along its main facade.
- Typical Maryland farmstead with log tenant house.

20/21 BELWARD FARM/WARD HOUSE

- 1891--SIGNIFICANT AS AN EXAMPLE OF A HIGH STYLE, LATE 19TH CENTURY FARMSTEAD.
- QUEEN ANNE HOUSE EXEMPLIFIES HIGH STYLE VICTORIAN ARCHITECTURE. THIS TWO-STORY FRAME HOUSE FEATURES SHINGLED GABLES AND A TWO-STORY PORCH WITH TURNED POSTS.
- BUILT BY IGNATIUS B. WARD, FARMER, STOREKEEPER, AND POST-MASTER FOR HUNTING HILL.
- THE ENVIRONMENTAL SETTING INCLUDES THE QUEEN ANNE STYLE HOUSE, SOME REPRESENTATIVE OUTBUILDINGS, AND THE SIGNIFICANT SHADE TREES WHICH COMBINE TO DEFINE THE HISTORIC FARMSTEAD. THE SETTING ALSO INCLUDES THE TREE-LINED DRIVE IN ORDER TO PRESERVE THE HISTORIC RELATIONSHIP OF THE FARMSTEAD TO THE ROAD. AT THE TIME OF DEVELOPMENT, SPECIAL ATTENTION SHOULD BE GIVEN THE SITING OF STRUCTURES TO PROVIDE A VIEW OF THE HOUSE FROM MD 28.

<p>There are two notable buildings on the site; a church and an abandoned rectory building, both in the gothic revival style.</p> <p>The church is a wooden, gable-roofed structure with five pointed-arch windows on either side wall and a bracketed canopy hood over the front door. In the gable is a round window with a multi-foil motif. The church has a polygonal apse with hipped-roofed wings. On the interior, ceiling ribs are supported by wall brackets. There is an organ loft forming a balcony at the entrance end.</p> <p>The cottage rectory stands adjacent to the church. It has a hooded canopy with bracketed supports and a transom-lighted doorway. Tall, narrow windows, a bracketed cornice, and irregular massing give the cottage a picturesque appearance.</p>
