Description:

Flint Hill I, constructed circa 1770, was previously surveyed by Sugarloaf Regional Trails in 1979. Since the previous survey, the house and outbuildings were demolished. All that remains of the buildings is a two-sided, stone chimney now located in the front yard of a circa 1994 house. The chimney appears to be the 2-sided smokehouse chimney described in the previous survey form. The remainder of the land has also been subdivided.

National Register Evaluation:

Flint Hill I, constructed circa 1770, was previously surveyed by Sugarloaf Regional Trails in 1979. The property is not eligible for the National Register of Historic Places, due to the demolition of all buildings associated with the property.

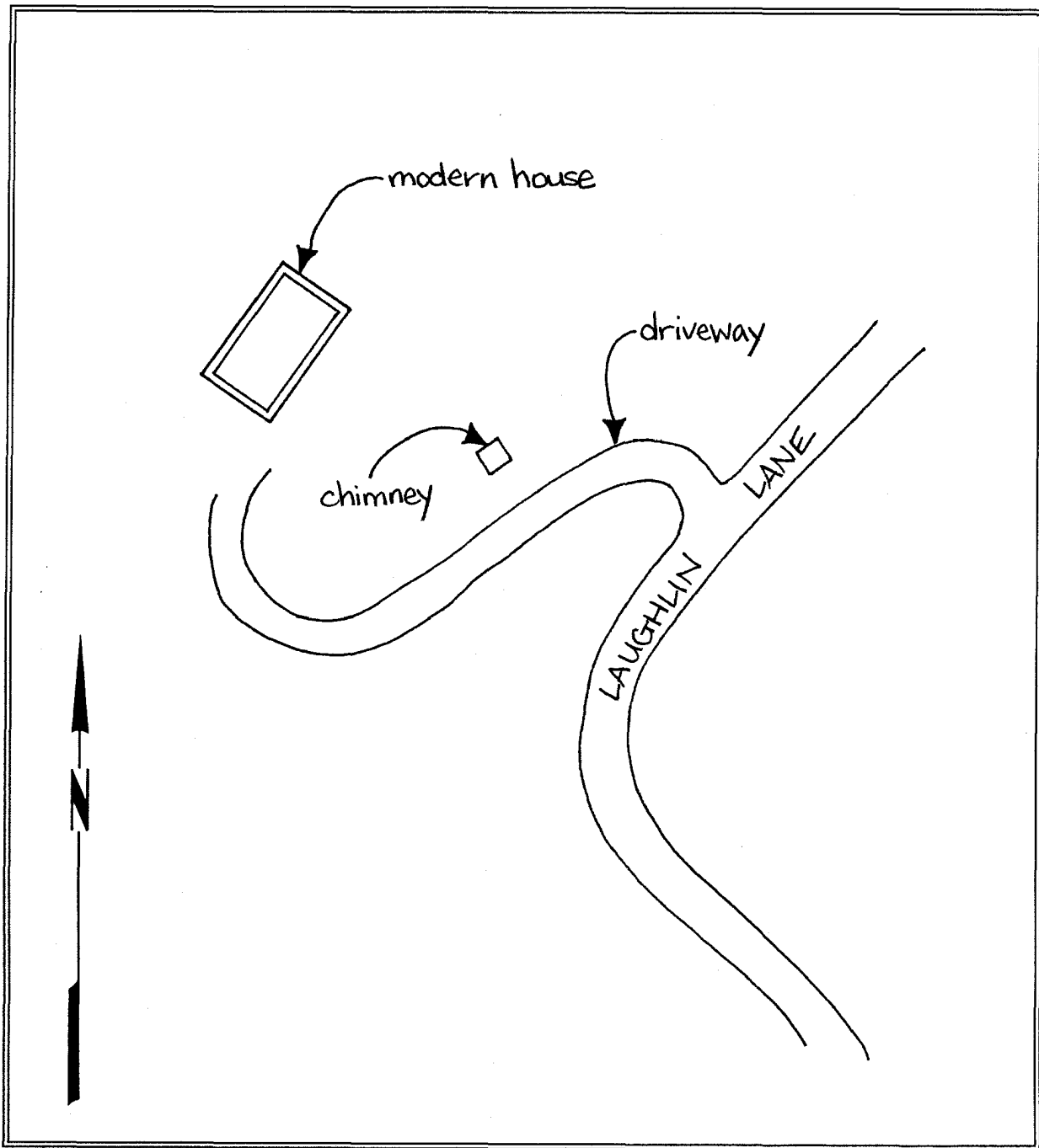

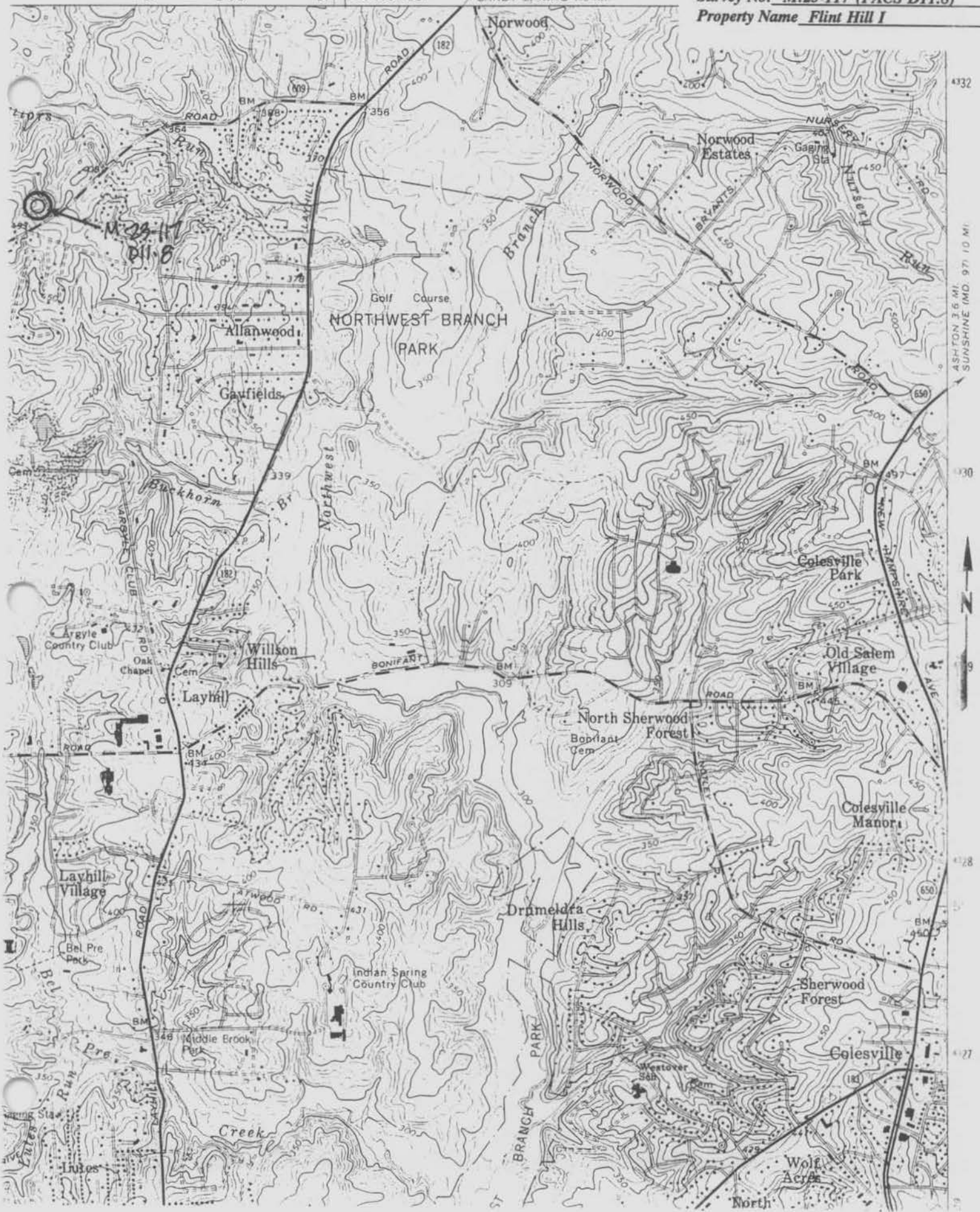

9. Description: This nine bay by two bay, two-and-a-half story house is set in the woods at the end of rutted and rocky road. This house was built in sections: the original two bay by one bay house faced east.

A three bay two-and-a-half story was added to the west and the house changed orientation. There is a one-and-a-half story two bay by two bay west house connected to the main house at the northwest corner. The house has six-over-six double-hung windows flanked by black wooden louvered shutters. The gable roof has raised seam metal covering.

10. Significance: Flint Hill I is the old family home of a branch of the Beall family, a family which was prominent not only locally but statewide for many generations. It is believed that Edward Beall and his bride Rachel Edmonston Beall moved to this property in about 1770 and built the log part of Flint Hill. Eden Beall, grandson of Edward and Rachel, passed it to his son Charles W.C. Beall in 1862. When Charles moved west in 1878 he sold the 156½ acres to Granville Stabler. Stabler also decided to move west and Flint Hill was bought by Edward C. Henderson, who lived there for 30 years.

Since that time Flint Hill has changed hands many times. Mr. & Mrs. Harry T. Whitlock, who purchased Flint Hill and 50 acres in 1933, modernized and renovated the old house. The present owner, who bought the house in 1965, is holding the land for development.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This nine bay by two bay, two-and-a-half story house is set in the woods at the end of a rutted and rocky dirt road.

Built on fieldstone foundations, this house was built in sections and faces south. The original one bay by two bay house faced east. A three bay by two bay, west addition changed the orientation of the house to the south. A west two bay by two bay one-and-a-half story house was linked by a two bay one-and-a-half story connector to the northwest corner of the main house. The entire house is sheathed in white clapboards.

There is a stone step in front of the south wooden paneled door. Above the door is a sign which says "Flint Hill". There is a screened porch at the east end of the house. It has a shed roof. A pair of French doors lead into the house. On the north elevation there is a one story lean-to with novelty siding. This lean-to leads into the two bay connector to the west section.

There are six-over-six double-hung windows flanked by green wooden louvered shutters. There is one four-over-two double-hung window in the west gable.

The house has a gable roof with raised seam metal covering. The cornice line is boxed and returned. There are two interior chimneys and one exterior chimney at the south gable end of the west section.

STATEMENT OF SIGNIFICANCE

Flint Hill I is the old family home of a branch of the Beall family, a family which was prominent not only locally but statewide for many generations. It is believed¹ that Edward Beall and his bride Rachel Edmonston Beall moved to this property in about 1770 and built the log part of Flint Hill. Edward's will left all of his real and personal estate to his wife.²

Eden Beall, grandson of Edward and Rachel, born in 1780, did live in this house and passed it down to his son Charles W.C. Beall by his will of 1862.³ Charles Beall lived at Flint Hill until 1878, when he moved to Missouri. He sold the house and 156½ acres to another local farmer, Granville Stabler.⁴ Stabler also decided to move west and sold Flint Hill to another neighbor, Edward C. Henderson, in 1884 for \$2,000.⁵ The Hendersons resided on the farm for 30 years, selling it in 1914.⁶

Since that time the property has changed hands eight times. Mr. and Mrs. Harry T. Whitlock, who purchased Flint Hill and 50 acres in 1933,⁷ modernized and renovated the old house. They also made several alterations, including the two story addition to the rear, during their ten year occupancy. The present owner, who bought the house in 1965, is holding the land for development.

DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

The house is a two story, frame structure with a stone foundation. The main (south) facade is three bays with a central doorway. The flanking windows are 6/6 double hung sash. On the east end, there is an external chimney, the base of which is hidden by a two story east wing. The doorway is flanked by pilasters that support a cornice over the door; these are modern replacements.

West of the house is a smokehouse. It has a braced frame and on the east end an exterior stone chimney with both interior and exterior fireplaces; the exterior fireplace was used for butchering and other domestic purposes, the interior fireplace for smoking meat.

Flint Hill I

THE ghost of Col. Ninian Beall, the legendary warrior of the American Provinces in the seventeenth century, may hover over the little house shown below. Although Ninian probably never visited this spot, one of his great-great grandsons is believed to have built the house, or at least to have brought his bride there in 1770.

The antique house is located on the north side of the road from Norbeck to Norwood, and is about sixteen miles from Washington. Three generations of Bealls were born in the little log house, and these descendants of the noble Colonel are proud to be able to trace their line of descent for seven generations directly back to him. A member of the seventh generation, who lives in Washington, has furnished records of the family.

Ninian Beall fought in the wars of Scotland, and shared the same fate as many others of his countrymen. Brought to the Colonies (about 1650) as an indentured servant (having been captured in the Battle of Dunbar), he became the commander of the Provincial forces in the Indian Wars, and attained a position of respect and influence.

For his services he was granted a tract of 795 acres along Rock Creek in 1703, which he named the Rock of Dunbarton. Ninian died in 1717 and left that plantation in Georgetown to his son, George. The headquarters of the Colonial Dames, later named "Bellevue," on Que Street and other notable Georgetown houses stand on some of that land.

Down the line of descent from Colonel Ninian, the Bealls of Flint Hill I are traced in the following order, according to his descendants: first Ninian, Junior, William, and Alexander, and Edward who was the first to live at Flint Hill. It is understood that Edward brought his bride, Rachel Edmonston, there to live after their marriage in 1770, and he may have been the builder of the house about that time. Edward was born in 1743, and died in 1797.

The next one to live at Flint Hill was Eden Beall, born in 1780. He first married Matilda Perry, by whom he had three children; then,

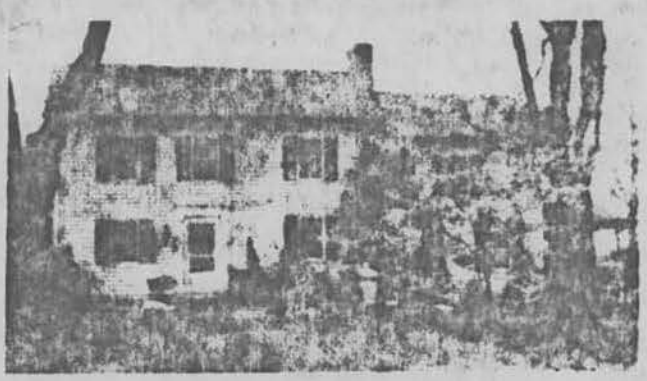
after her death he married Priscilla Perry Beall, by which marriage there were five children. The second of Eden and Priscilla—Charles Alexander Beall, born in 1832—inherited the farm, and was married to Catharine Miles Perry in 1864.

The one remaining child of this marriage, now living in Washington, is Alice (Beall) Palmer, a widow who was a little girl when her parents left Montgomery County and settled in Missouri. Through the courtesy of Mrs. Palmer, the information contained herein about the Bealls of Flint Hill and elsewhere has been presented.

Eden Beall added to the plantation, as is shown by one deed dated December, 1814, from John Ellicott, for parts of Bradford's Rest, Beall's Plantation, Batchelor's Forest, etc., without giving the exact acreage.

One other child of Eden and Priscilla Beall was George Washington Columbus Beall, born 1837. He was a brother of Charles Alexander and married Mary Ann Palmer. Another brother was Thomas John Beall who married Catharine Goldsborough Owen, daughter of Washington Winder Owen of Locust Hill, which property the latter couple inherited.

By a division of the Flint Hill farm in 1869, G.W.C.B. received as his "dowry" 193 acres, and Charles Alexander received his part, consisting of 156 acres. G.W.C.B. sold his part which contained the "Amersley" farm, for years the home of T. B. Stabler, and bought a

300-acre farm near Derwood, with a fine brick house on it, known as Needwood farm, the home in recent years of Mr. and Mrs. W. F. Stickle.

Like the Owen family of Locust Hill, the Bealls were active in the affairs of the early churches of the State. In 1758, a petition was sent to the Governor and Assembly of Maryland signed by James Beall, William Beall, Robert and George Beall, Sr., and George, Junior, requesting that the Parish of Prince George's be divided in half. The parish was declared to be so extensive that it was very difficult for "the great part of the inhabitants to repair to public worship, to the great discouragement of religion and virtue."

When Charles Alexander Beall decided to move to Missouri, he sold Flint Hill to Granville Stabler, a farmer of the Sandy Spring neighborhood. He was a son of Charles and Sarah Kirk Stabler, of The Cottage, and was born in 1864 on "The Manor."

Granville did not remain long at Flint Hill, and in November, 1884, he conveyed the place to Edward C. Henderson, another local farmer. The transfer gave the acreage as 156, and the sum paid therefor as \$2,000. A few years after Stabler had moved to Missouri, he settled in California, where he lived for about forty years, dying there at the age of 73 in 1927.

After ownership and occupancy for a number of years, Edward Henderson sold Flint Hill, which until the year 1930 was in the hands of a number of different owners. One of these was John A. Brickley, a real estate dealer still very active in the area.

In 1933 the home with about fifty acres was sold to Harry T. Whitlock, the head of an old firm in Washington. He and Mrs. Whitlock modernized the house, brought in the electric power line, and beautified the grounds with box bushes and other plantings, restoring the early charm of the place. A side porch shown in the picture, and a two-story addition in the rear, were added. On the second floor of the

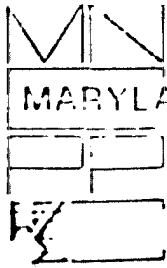
latter, two bedrooms and a bath were included, and on the first floor, a kitchen and bath. The pleasing antique character of the old part was wisely retained.

After the Whitlocks had enjoyed the quiet, peaceful home for ten or more years, they sold it (with 35 acres) to Joseph William Ballantine in 1947, who changed the name to "Coromandel." Meaning "Wood of Ceylon," the name was applied by the new owners because of their long residency in the Far East, and their admiration for that superior wood.

Mr. Ballantine was employed for twenty-seven years by the State Department, twenty of them spent in Japan and six in China. Although now retired, he is still very busy on special work for the Brookings Institution, and he finds ample physical recreation at Coromandel, which he and Mrs. Ballantine were enjoying greatly after so many years' residence in the Orient. They have furnished the house with many unusual Oriental pieces. (It is necessary to report the death of Mrs. Ballantine on January 24, 1952, to the great sorrow of the community where she had so endeared herself to so many.)

The ancient house is built of logs covered with weatherboard. The right lower section to the east is the original part, probably built in 1770, although the main part is believed to be nearly as old. The room at the right of the front door has the quaint old stairway with a primitive handrail and spindles; hand-hewn beams are exposed in the ceiling. This room has a very old fireplace with sloping brickwork and soapstone back. On the second floor above this part three bedrooms and a bath have been added.

The room in the right lower section, now used as a dining room, although it was originally a kitchen, has a similar old and wider fireplace with the crane still in place. It is wainscotted up four feet from the floor, and also has exposed hand-hewn beam ceiling. Some of the original wide pine floors remain in use.

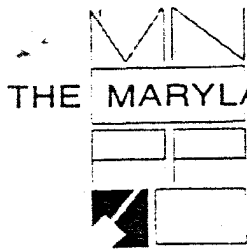

SITES NOT RECOMMENDED FOR REGULATION UNDER THE
HISTORIC PRESERVATION ORDINANCE CHAPTER 24A OF THE
MONTGOMERY COUNTY CODE

The following sites have been reviewed by the Montgomery County Historic Preservation Commission and were found not to merit designation of the Master Plan for Historic Preservation. If not included in the Master Plan, these resources may be removed from the Locational Atlas and Index of Historic Sites in Montgomery County. If removed from the Locational Atlas, the sites will no longer be governed by the Moratorium on Alteration and Demolition, Section 24A-10 of the County's Historic Preservation Ordinance. The sites will, however, remain on the Maryland Historical Trust's Inventory.

The following sites were found by the Preservation Commission to be too greatly altered from the period of their architectural or historical significance or not to meet Ordinance criteria for designation.
