The Ramsburg House is a 1½-story, 4-bay, stone Tudor Revival-style house on the north side of Gracefield Road in the Fairland vicinity, Montgomery County. Constructed in 1946, the building is T-shaped in plan with a front cross-gable entry vestibule. Forming the stem of the T-shaped plan is a 1-story stone garage with a second story vinyl-sided addition, which projects from the rear of the structure.

The structure has a side-gable roof, with a cross-gable entry vestibule and an exterior stone chimney on the front elevation. It is of masonry construction with stone veneer, and it has a stone foundation. The majority of the windows are wood casement. The front elevation has a stone stoop leading to the entrance.

The front, or south facade has an entrance in the cross-gable vestibule. The entrance vestibule has a lancet arch-shaped door with three stepped lights, a 9-light circular window above the doorway and a rectangular fixed window with a diamond glazing pattern east of the door. The front elevation also has a pair of 12-light casement windows on both sides of the vestibule.

The west elevation has a 1-story flat roof porch. The porch is supported by two stone posts and has a flagstone floor. Centered on the elevation is a single 15-light glass door. A triple 12-light casement window is located to the south of the door, while a pair of 12-light casement windows is located to the north. The second story has a pair of 12-light casement windows in the gable end. A stone garage, with a vinyl-sided second floor addition extends from the rear elevation. The west elevation of this section has a single 12-light casement window on the first story and a pair of 12-light casement windows on the second story.

The rear, or north elevation has a symmetrical fenestration pattern. The first floor has a pair of 12-light casement windows on each side of the garage section. The first floor of the projecting garage section has a single 12-light casement window. A pair of 12-light casement windows is located in the second story addition to the garage section.

The east elevation has an irregular fenestration pattern. The basement level has a glass and paneled door centered in the elevation and is accessed from the west by a set of concrete steps. Above the basement entry, on the first story, is a glass and panel door with a shed roof hood supported by two wooden posts. This entrance is approached from the north by a set of concrete steps parallel to the elevation. The platform of the concrete stoop forms a protective covering over the basement entry. To the south of this entry is a three-sided canted bay with a hipped roof. The center window in the bay is a 16-light fixed window and is flanked by two 12-light casement windows. To the north of the entrance is a single-light plate glass window. The second story has a pair of 12-light casement windows in the gable end.

Alterations to the property include a second story addition to the garage section.

There are no outbuildings associated with this property. A stone hearth/grill is located north of the house.

Prepare both a summary paragraph of significance and a general statement of history and support.

Jerimiah and Henri Mackle purchased 1.01 hectares (2.5 acres) of land from George McGeney in 1945. Half of that parcel, .50 hectares (1.25 acres), was sold to Charles and Eleanor Ramsburg in 1946. The Ramsburgs built the house shortly after the purchase of the lot. The remainder of the parcel was purchased by the Ramsburgs in 1963 for a total of 1.01 hectares (2.5 acres). In 1994, the house and its 1.01 hectares (2.5 acres) was sold to Joyce and Walter Ramsburg from the trustees of Eleanor Ramsburg.

The Ramsburg House is located on the north side of Gracefield Road in the Fairland vicinity. Fairland is located on land originally patented to Archibald Edmonston in 1720 as "Deer Park" in what was then Prince George's County. "Deer Park" was a grant of 276 hectares (682 acres) of land between the Paint Branch and Little Paint Branch, and from approximately Randolph Road to Briggs Chaney Road (Boyd 1879: 38).

Beginning in the 1880s, the economy of Montgomery and Prince George's counties began to shift away from agriculture, becoming increasingly more dependent upon the federal government and the jobs it provided (M-NCPPC 1993:25). The combined influences of an expanding capital city, speculative developers, and easier, more convenient modes of transportation stimulated suburban growth in both Montgomery and Prince George's counties. However, Fairland was far enough away from the District of Columbia to remain a small and rural community. In the decades after the Civil War, Fairland had a population of about 50 people, an Episcopal church, a schoolhouse, and a store.

The automobile and an improved system of roads offered further opportunity for suburban expansion. New communities appeared, in some cases quite distant from railroad and streetcar lines. Although Fairland remained a small community until after the Second World War, development occurred along the Columbia Pike. The historic crossroads of Fairland has been replaced by modern development.

The Ramsburg House is an example of post-World War II development. A common building type in the post-World War II period is the one to two-story side-gable cottage with Revival style detailing. These buildings are commonly designed with Colonial Revival and Tudor Revival features. The Ramsburg House is a side-gable cottage in the Tudor Revival style. The Tudor Revival style is based on early English building traditions and is identified by a steeply pitched roof, often side-gable with cross-gables, half-timbering or other exterior wall elaboration, multiple window groupings, including casement windows and diamond glazing patterns, and a prominently located chimney.

NATIONAL REGISTER EVALUATION:

Constructed in 1946, the Ramsburg House is not eligible for the National Register of Historic Places. The property is not eligible under Criterion A, as research conducted indicates no association with any historic events or trends significant in the development of national, state or local history. Historic research indicates that the property has no association with persons who have made specific contributions to history, and therefore, it does not meet Criterion B. It is not eligible under Criterion C, as it lacks architectural distinction. Buildings, such as the Ramsburg House, were frequently built during the post WWII period. This structure does not individually represent a contribution to the architectural history of its type or period. Finally, the structure has no known potential to yield important information, and therefore, is not eligible under Criterion D.




