9. Description: This six bay by one bay, two and a half story house sits close to the road facing east. The house has light green novelty siding. There is a porch on the east elevation with a half-hipped roof and supported by six chamfered wooden posts. The south porch has a shed roof supported by one chamfered post. The north two story porch is open at first level, and screened-in at the second level. There are two-over-two double-hung windows, some flanked by white wooden louvered shutters. At the south end of the east elevation, first level, two windows extend down to the porch floor. There are single diamond windows in the east and west cross gable peaks. The house has a gable roof with red raised seam metal covering, two interior and one exterior chimneys, and is built on fieldstone foundations.
10. Significance: The Glen Store, situated in the Watts Branch valley, is a good example of a rural, turn-of-the-century combined residential-commercial structure.
- Since the early 19th century energy from Watts Branch was used to operate the mills in this vicinity; Lucy Peters purchased the saw and grist mill in 1884. During the 1890s her son, George Fountain Peters, constructed this dwelling/store in the small community of Glen, near Tulip. Fountain Peters' store became the post office for the two communities in 1907, and they were henceforth both called "Glen".
- The store section was vacated by 1937, and the property sold by Peters' widow in 1952. The present owners were deeded the property in 1972.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This six bay by one bay, two and a half story house sits close to the road facing east.

Built on fieldstone foundations, the house has light green novelty siding. There is a porch on the east elevation. It has a half hipped roof which has a decorative porch screen and is supported by six chamfered posts on square bases. There are two doors on the east elevation: the south door is glass and wooden paneled; the north door is glass and wooden paneled. There is a porch on the south elevation. It has a shed roof (with a decorative porch screen) supported by one chamfered wooden post. The south door is glass and wooden paneled. The north elevation has a two story porch. The first level is open and three chamfered wooden posts support the screened second story. This porch has a shed roof. There is a glass and wooden paneled door at the first level.

There are two-over-two double-hung windows. Some are flanked by white wooden louvered shutters. At the south end of the east elevation, first level, two of the windows extend down to the porch floor. There is a six light casement window in the south gable end. There is a diamond window in each of the east and west cross gables.

The house has a gable roof with cross gable peaks on the east and west elevations. The roof has red raised seam metal covering. There are two interior chimneys and one exterior fieldstone chimney at the north gable end.

STATEMENT OF SIGNIFICANCE

The Glen Store, situated in the Watts Branch valley, is a good example of a rural, turn-of-the-century combined residential-commercial structure.

The building is located upon a tract of land which from the early 19th century had been associated with a milling complex employing the water power provided by Watts Branch. The grist mill, and later saw mill, located on the western bank of the stream, was purchased in 1884 from George R. Bell by Lucy J. Peters.¹ This property consisted of 86 acres of "Clagetts Folly" and "Brothers Industry", lying on either side of Watts Branch. Sometime during the 1890's, Lucy Peters' son, George Fountain Peters, married, and soon thereafter constructed the subject building upon a section of his mother's land. The dwelling/store is believed to have been built c. 1899.

While Fountain Peters store was located in the vicinity of a small community referred to as "Glen", it appears that the neighborhood surrounding the Peters' store received a separate designation, that of the town of "Tulip". This is indicated in a passage in the "Glen Items" column of the March 23, 1900 issue of the Montgomery County Sentinel, which states

...our little nearby town of Tulip has a new merchant, Mr. Fountain Peters, who seems to be doing a flourishing business.

This town name was short lived, however, for with the transferral of the post office across the branch to Fountain Peters' store, ca. 1907, the two communities were known by the single title, "Glen".

The dwelling/store remained in the Peters family until 1952, though the store section was described as "vacant" as early as 1937.² After the death of George Fountain Peters, his widow conveyed the building and a surrounding 10.310 acres to Ralph and Renee Gunkel.³ The house was purchased by the present owners in 1972.

SUBJECT: Amendment to the Approved and Adopted Master Plan for Historic Preservation in Montgomery County, Maryland

WHEREAS, in September, 1983, the Montgomery County Planning Board transmitted to the Montgomery County Council the Final Draft Amendment to the Historic Preservation Master Plan, proposing the addition of several historic sites for inclusion in the Master Plan and the removal of several sites from the Locational Atlas and Index of Historic Sites in Montgomery County, Maryland; and

WHEREAS, on December 13, 1983, the Montgomery County Council held a public hearing wherein oral and written testimony was received concerning the Final Draft Amendment to the Historic Preservation Master Plan; and

WHEREAS, on May 22, 1984, the Council Planning, Housing and Economic Development Committee reviewed the Final Draft Amendment to the Historic Preservation Master Plan and the issues raised at the public hearing with the Montgomery County Planning Board, staff and affected parties; and

WHEREAS, the Montgomery County Council reviewed the recommendations of the Planning, Housing and Economic Development Committee at a worksession held on June 11, 1984.

NOW, THEREFORE, BE IT RESOLVED by the County Council, sitting as a District Council for that portion of the Maryland-Washington Regional District within Montgomery County, that -

The Historic Preservation Master Plan is hereby amended by the inclusion of the following sites and/or resources:

- Associated for more than 100 years with the Magruder family, prominent in the early history of the State and County.
 - Farm cultivated as early as 1734, reclaimed in the mid-1800's by Otho Magruder, an early proponent of agricultural innovation in the County.
- 24/13 Pleasant View Church #2 (p. 10)
- 19th Century vernacular rural black church with unusual truncated steeple.
 - The three acre parcel includes a cemetery, privy and the Quince Orchard Negro Schoolhouse built c. 1875. The entire parcel should be retained as the environmental setting.
- 24/21 Pleasant Hills (p. 11)
- Built circa 1763—Fine example of Georgian brick construction and one of the oldest brick homes in the County.
 - Originally associated with the Gassaway family early settlers in the Darnestown area of the county.
 - To preserve the integrity of this site any development that occurs on the property should be effectively clustered away from the main house.
- 29/3 Glen Store and Post Office (p. 12)
- Built circa 1899—Good example of a rural, turn-of-the-century combined residential/ commercial structure.
 - Rural Victorian design which is the last remnant of the historic Glen community.
 - The Approved and Adopted Master Plan for the Potomac Subregion recommends improvement of South Glen Road to a primary street. If and when the road is widened, this amendment recommends the center line be shifted to the east in the vicinity of the store so the improvement does not adversely affect the store and the historic relationship of the site to the roadway can be retained.
- 29/16 Locust Grove I (Magruder House) (p. 13)
- Built circa 1773—Original Federal style brick residence; remodeled circa 1895 in the Victorian style.
 - Associated with Samuel Wade Magruder, a patriot in the American Revolution and one of the "founding fathers" of Montgomery County.
 - The boyhood home of William Wurt, well-known author and lawyer who served as the Attorney General of the United States from 1817 to 1829 under the presidencies of James Monroe and John Quincy Adams.
