SCOPE OF WORK

1- Modify the reconstructed retaining wall at the left (north) side of the driveway to match the previously existed retaining wall as closely as possible.

2- Construct a new retaining/ garden wall at the right (south) side of the driveway to match the previously existed retaining wall as closely as possible. And, backfill the south side of the property adjacent to proposed south retaining wall to a level similar to what had previously existed on the site.

3- Modify the as-built driveway to an exact width of 16 ft.

4- Install 36" h fixed planters on the side patio facing Surrey st.






