The Montgomery County Historic Preservation Commission (HPC) has reviewed the attached application for a Historic Area Work Permit (HAWP). This application was <u>Approved with one (1) condition</u> at the February 18, 2025 HPC meeting:

1. The applicants must plant two native shade trees with at least 2.5" d.b.h. within one year of the approval in a suitable location to be determined by the Town within the right of way.

The HPC staff has reviewed and stamped the attached submission materials.

THE BUILDING PERMIT FOR THIS PROJECT SHALL BE ISSUED CONDITIONAL UPON ADHERENCE TO THE ABOVE APPROVED HAWP CONDITIONS AND MAY REQUIRE APPROVAL BY DPS OR ANOTHER LOCAL OFFICE BEFORE WORK CAN BEGIN.



While it is my opinion that these trees are in a state of decline (evidenced by deadwood, multiple cavities, included the bark and recent limb failure), these trees are not dead and could be pruned "hard" and last another 5-10 years.

However, if this course of action is pursued, the trees should be reexamined annually and treated as needed. * because trees may continue to drop limbs
