SUBJECT: Agenda Item III. 1., Determination of Substantial Alterations

Lucille Johnson is applying to complete grading of a lot within the Takoma Park Atlas historic district, 106 Tulip Avenue. This lot was part of B.F. Gilbert's original parcel and contains two outbuildings which are thought to be original to that period. The Gilbert house is gone. The lot also contains many significant trees. Mrs. Johnson will provide a tree survey. The issue to be decided is whether the clearing and grading of the lot can be done without damaging either the trees or the buildings (which are unoccupied). You should be aware that the neighbors are distressed by the lack of maintenance of the buildings and the substantial clearing which has already taken place. There is a stop work order in effect.
