Colesville Area of Silver Spring in Montgomery County, Maryland, is a mixture of middle class and upper middle-class neighborhood with aging cottages and newly built developments. Seventy-seven years ago the contrasts in these few square miles were no less striking, not just between rich and poor, powerful and powerless, but also between black and white. In the 1920s, Colesville was a rural community of small farms and dirt roads settled by African American families barred from all-white areas nearby. Then there was a brand-new school building in the neighborhood with an all-black enrollment. But in 1927, law segregated the school. Black students, from first through 6th grade, traveled miles by foot to get to The Smithville Colored School, while white students rode past them on buses headed to better-equipped buildings.

Like much of the South in the Jim Crow era, public schools in Montgomery County were separate and profoundly unequal. The average per pupil expense was less than \$14. White teachers were paid more than black teachers and whites had a longer school year. There were an average of 27 students for every white teacher, compared to 44 students in black classrooms. Black schools had no new equipment, just tattered books and scratched-up desks handed down from white schools.

Despite these insults, African American families were pleased to dedicate Smithville Colored School in 1927. And even in a new century — almost fifty years after school segregation was outlawed, after a generation of busing to integrate classrooms, and now a return to neighborhood schools in Montgomery— the Smithville School is still a source of pride.

Built in 1927, the Smithville Colored School was one of several primary schools for African Americans in Montgomery County. It was one of eight constructed in the County with financial assistance from the Julian Rosenwald Fund, which provided funds to build nearly 5000 public schools from 1917 to 1932. The Smithville School was closed in 1954.

The applicants have just completed a renovation of the building for the Smithville School Museum and Education Center, which is scheduled to open on February 19, 2005.

#### **PROPOSAL**

The applicants are proposing the installation of a historic marker in front of the building. The marker would be six feet tall, bronze, and would have a photo of the historic resource above the text (see example of sign type in Circle **7**. The sign would be located inside the fence in front of the school. Sample text has been provided (see Circle 2 ) and the final text and photograph selection would be reviewed by staff.

#### **STAFF DISCUSSION**

Staff used the Secretary of the Interior's Standards for Rehabilitation as a guide, specifically:

Standard #2: The historic character of a property will be retained and preserved. The removal of distinctive materials or alteration of features, spaces, and spatial relationships that characterize a property will be avoided;

Standard #9: New additions, exterior alterations, or related new construction will not destroy historic materials, features, and spatial relationships that characterize the property. The new work shall be differentiated from the old and will be compatible with the historic materials, features, size, scale and proportion, and massing to protect the integrity of the property and its environment.

The applicants are clearly very aware and appreciative of the importance and significance of this historic resource and staff is pleased to see the building's restoration and reuse as a museum and educational center. The applicants have been working closely with the Education and Outreach Planner from Park and Planning's historic preservation section on the design and material selection for the marker, and it is the exact same size and type of bronze marker that Park and Planning has installed at historic sites. Staff recommends that the staff Education and Outreach Planner continue to work with the applicants on the final wording and historic photograph selection for the marker.

This marker would not have an adverse impact on the historic resource and is approvable using the Secretary of Interior's *Standards for Rehabilitation*. Staff is recommending approval with one condition.

#### STAFF RECOMMENDATION

Staff recommends that the Commission approve the HAWP application with the condition listed at the beginning of this report as being consistent with Chapter 24A-8 (b) 2:





Smithville School before renovation 1998 Front




Past students and teachers of the Smithville School Oct 1997






Smithville School totally renovated 2005 Front






SMITHVILLE COLORED SCHOOL A JULIUS ROSENWALD SCHOOL

BUILT IN 1927, THE SMITHVILLE COLORED SCHOOL WAS ONE OF PRIMARY SCHOOLS FOR AFRICAN **AMERICANS** MONTGOMERY COUNTY. IT WAS ONE OF SIXTEEN CONSTRUCTED IN THE COUNTY WITH THE FINANCIAL ASSISTANCE FROM THE JULIAN ROSENWALD FUND, WHICH PROVIDED FUNDS TO BUILD NEARLY 5000 PUBLIC SCHOOLS FROM 1917 TO 1932. ALL OF THESE SCHOOLS WERE BUILT IN AFRICAN AMERICAN COMMUNITIES THROUGHOUT THE SOUTH AS A WAY OF GIVING BLACK STUDENTS A BETTER OPPORTUNITY IN EDUCATION. LAND ON WHICH THIS SCHOOL WAS BUILT WAS PROVIDED BY A LANDOWNER, AND OTHERS IN THE COMMUNITY RAISED MONEY TO ADD TO THE ROSENWALD FUND. IN ADDITION, THE COMMUNITY DONATED MATERIALS AND LABOR TO BUILD THE SMITHVILLE SCHOOL. MONTGOMERY COUNTY ALSO PROVIDED FUNDS FOR CONSTRUCTION OF THE SCHOOL. MONTGOMERY COUNTY BOARD OF EDUCATION MANDATED THE SCHOOL BE TURNED OVER TO IT. IN RETURN, THE BOARD PROVIDED UNDERPAID TEACHERS, USED AND TATTERED BOOKS, AND LIMITED SUPPLIES. THE COOPERATIVE EFFORT BETWEEN JULIUS ROSENWALD AND THE AFRICAN AMERICAN CITIZENS GAVE A TREMENDOUS BOOST TO PUBLIC EDUCATION DURING A TIME OF SEGREGATION IN A SEPARATED BUT EXTREMELY UNEQUAL ENVIRONMENT. IN SPITE OF THE DISPARITY OF TREATMENT, THESE STUDENTS BECAME DOCTORS, LAWYERS, TEACHERS, AND SKILLED TRADESMEN. THE SMITHVILLE SCHOOL WAS CLOSED IN THE SPRING OF 1954.





SMITHVILLE COLORED SCHOOL A JULIUS ROSENWALD SCHOOL

BUILT IN 1927, THE SMITHVILLE COLORED SCHOOL WAS ONE OF SEVERAL PRIMARY SCHOOLS FOR AFRICAN **AMERICANS** MONTGOMERY COUNTY. IT WAS ONE OF EIGHT CONSTRUCTED IN THE COUNTY WITH THE FINANCIAL ASSISTANCE FROM THE JULIAN ROSENWALD FUND, WHICH PROVIDED FUNDS TO BUILD NEARLY 5000PUBLIC SCHOOLS FROM 1917 TO 1932. ALL OF THESE SCHOOLS WERE BUILT IN AFRICAN AMERICAN COMMUNITIES THROUGHOUT THE SOUTH AS A WAY OF GIVING BLACK STUDENTS A BETTER OPPRTUNITIES IN EDUATION. LAND ON WHICH THIS SCHOOL WAS BUILT WAS PROVIDED BY A LAND OWNER AND OTHERS IN THE COMMUNITY RAISED FUNDS TO ADD TO THE ROSENWALD FUND. IN ADDITION THE COMMUNITY GAVE MATERIAL AND LABOR TO BUILD THE SMITHVILLE SCHOOL. THE MONTGOMARY COUNTY BOARD OF EDUCATION MANDATED THE SCHOOL BE TURNED OVER TO THEM IN RETURN FOR PROVIDING UNDER PAID TEACHERS, USED TADDARED BOOK AND LIMITED SUPPLIES. THE COUNTY ALSO PROVIDED FUND FOR ITS CONSTRUCTION. THE COOPERATIVE EFFORT BETWEEN JULIUS ROSENWALD AND THE AFRICAN AMERICAN CITIZENS GAVE A TREMENOUS BOOST TO PUBLIC EDUCATION DURING A TIME OF SEGRGATION IN A **SEPERATED BUT** EXTREMLY UNEOUAL ENVIROMENT. THE SMITHVILLE SCHOOL WAS CLOSED IN THE SPRING OF 1954. THAT WHICH WAS DESIGNED TO SEPARATE US WILL UNITE US.
